Reserve your space early as we have limited spaces this year.

Vendors need to be set up by 10:00 AM on event day. NO exceptions.

NO refunds for early departure.

Vendors must provide proof of Insurance showing City of Riverside AND Sgt John Basilone Lodge # 2748 on binder. NO exceptions. This coverage must be in a minimum amount of \$1,000,000 and \$2,000,000 aggregate.

Vendors must keep their area clean and available for inspection by fire officials and health department at all times.

ALL vendors must bring their own fire extinguisher.

Vendors are responsible for their own sales tax liability.

NO vendors may serve ANY alcohol whatsoever. This will be strictly enforced throughout the day!

Vendors may not sell whatever they want. Any and all items must be approved by Festa committee. We are trying to avoid multiples of same products offered. NO refunds for bad weather or other acts of God or causes beyond our control.

Vendors may not serve or sell any beverages not approved by committee.

Festa Committee reserves the right to reject any application for any reason whatsoever. Spaces are on a first come basis.

The fee for a 10 x 10 food vendor space is \$300.00. Food vendors also pay an additional fee of 50.00 to cover cost of blanket health permit. The event will secure the permit. Each booth has electricity and one 8 foot table.

The fee for a 10 x 10 NON food booth is \$250.00. These spaces also have electricity and one 8 foot table.

The event committee reserves the right to remove or prohibit any exhibits it deems objectionable or will detract from the theme of the event. This includes any and all printed matter.
